**PADUCAH TRANSIT'S MOBILE
DRIVER TRAINING SIMULATOR**

In order to enhance and attract more drivers to the DTA Fall Conference and Roadeo NDDOT along with DTA contacted Paducah Transit Authority to lease the simulator for the event. The newly remodeled state-of-the art driver simulator was paid for with RTAP funds. Bus, cutaway and car simulator training involves the use of a simulated bus driving compartment, which provides behind the wheel, hands-on training in a virtual environment. This technology has been effective in improving safety and can be cost-effective addition to driver training programs for small operators when taking a regional approach.

The simulator was in Brookings for 2 ½ days and I believe everyone that went through the training really enjoyed it. The Roadeo judges encouraged everyone to participate in the training and the simulator trainers did an outstanding job with all our drivers and directors from South and North Dakota. I heard a lot of surprising comments about the experience after people went through it, I don't think anyone was expecting so much technology in a tractor trailer.

We at NDDOT can see the value of a great tool and hope to get it back to North Dakota sometime. By speaking with the Transit Directors that had the time to go through it I know they are looking forward to its return.

MAKING YOUR CASE

Carol Wright of SURTC gave us a very informative presentation on effective local government & funding presentations. "How to get your issues heard above the others is a challenge".

Focus on educating and influencing: Choose a message, coordinate your delivery, pick the appropriate venue to make your point. Prepare—be accurate & knowledgeable. Have clear objectives and clear results and ALWAYS be honest. Never exaggerate your needs.

Use others to help send your message, i.e community groups, riders, people from centers you transport to. Build layers of support which will have a domino effect. Remember, all politics is local.

Timing: Know the decision making process and who controls the decisions. Craft your approach with the opposition in mind. Keep local media informed and use them to do public "thank you" for support you have received. Keep your supporters in the loop at all times. Creating support before your need arises will pay off in the long run.

REMARKS

It's not often that we have an opportunity to hear from Region 8's Jennifer Stewart, Dale Marsico, the Executive Director of Community Transportation Association of America and both Paul Benning and Bruce Lindholm with the North and South Dakota Department's of Transportation.

Jennifer brought greetings from the new Region 8 Administrator Linda Gehrke who was unable to attend. Comments regarding the current transportation bill and work with tribal grants and efforts to continue the good work were given.

Dale Marsico strongly encouraged our DTA members to share the goals of their projects so that they are available to his office when the work on the new transportation bill begins. Dale shared that the statewide book South Dakota puts together each year is a document used by Secretary Rogoff and our Congressional delegates-simple but effective. Speaking briefly about the new Legislation, MAP-21, Lindholm welcomed all the attendees to the conference. With changes in the Transportation bill Bruce stated that agencies in SD would see increases in their grant requests.

ND's Paul Benning recognized the vital service providing mobility for people living in small rural communities and transit. It allows those people to continue living in their own homes when they can't drive any longer or chose not to drive. ND is currently working with two test regions in the state to help improve coordination and provide better public transit services statewide.

Both DOT's shared that while transit is important their jobs also include other responsibilities and they rely on great staff to carry on the day to day work. The efforts of agencies providing transit services was recognized and applauded and all were encouraged to do the good work they do each and every day.
