Handi-Wheels Transportation An Equal Opportunity Transit Service and Employer

Handi-Wheels Transportation began over 40 years ago through a grassroots effort by individuals using wheelchairs and their families to purchase a wheelchair accessible van. Members of the Red River Valley Handicaps Club collected over 1,700,000 Betty Crocker coupons over an 18 month period resulting in a check from General Mills for \$8,500 to be used to purchase the van. Prior to that time, the only method of transportation for



individuals using wheelchairs was an ambulance. This was the first such van in the Fargo metro area that was operated as a service to the community.

In the beginning, Handi-Wheels had just one van and just one driver. Times have changed. Now, they have 4 accessible buses and 6 drivers and provided over 11,000 rides in 2015 operating within the city limits of Fargo and West Fargo, North Dakota.

Handi-Wheels continues to provide accessible and affordable transportation service to individuals who have a disability as well as to others who cannot drive for themselves. Over 64% of their passengers have a disability and 27% of the ridership require the use of a lift to board the bus. Of the total number of rides they provide, 80% are medical-related and 99% of these passengers qualify for medical assistance. These passengers ride free-of-charge and the ride is billed to North Dakota Medicaid on their behalf.

In addition to providing rides to people with disabilities, Handi-Wheels has also had people with disabilities volunteering and working in its office as well as serving on its board. "The visionaries who were the founders of Handi-Wheels Transportation were themselves people with disabilities. Throughout its 41 year history as a nonprofit organization, people who have disabilities, have been a vital part of its operations," said Board President Allan Peterson. Executive Director and wheelchair user, Tonna Horsley, started out as a volunteer one day a week six years ago, then served as a VISTA Volunteer for 4 years, and then the Board hired her as the executive director. "For me personally, if I didn't work at Handi-Wheels I would have a more difficult time securing employment anywhere else. Here I have the flexibility of living and working in the same building. Handi-Wheels provides me the flexibility I need," said Horsley.
